1 Executive Summary

Disruptor of the football betting industry

Goal Bonanza is a self-regulating, blockchain powered football betting platform based on ERC20 token standard. It offers fresh and new football betting experience by combining lottery like crowd betting on 10 possible football game final score outcomes where the crowd drives the potential returns, unlike traditional bookmakers and betting exchanges that offer unattractive odds and low returns. The bigger the crowd the bigger are the potential returns easily reaching six figures. In simple terms, **imagine \$100,000+ in returns on 1\$ bet by successfully predicting the final score of a football game out of 10 possible outcomes. That is Goal Bonanza and much more.**

In addition to the unique game mechanics, Goal Bonanza revolutionary concept taps into basic desires and needs of users' impulses which revolve around the idea of profits, status, achievement, competition and community collaboration. Goal Bonanza applies gamification mechanics to engage and motivate users to play in order to win rewards, badges and points, that are used to elevate their status and privileges, and to showcase their talents, expertise, and accomplishments.

Build on ethereum platform and adopting ethereum as the underlying game currency, Goal Bonanza will significantly contribute to the crypto-community and the ethereum platform by increasing the demand for ethereum cryptocurrency, increase its value, and induce adoption in the global betting marketplace.

Goal Bonanza doesn't require the use of fiat currency for playing therefore it is outside gambling regulatory bodies and jurisdiction and therefore a **non-regulated stateless business**. Operations fudging and dividends payouts is performed in convertible ethereum cryptocurrency. In year 3 we expect to reach a total of **6.34m active players and generate earnings of \$11.7 million.**

Introduction

Sports betting is a very popular type of gambling that involves predicting sports results and placing a wager on the outcome.

It has become the fastest growing market segment within gambling worldwide, and now dominates, accounting for nearly half of the total online betting market.

A fifth of sports betting takes place via mobile, and this is expected to reach 45 per cent by 2018.

The consolidated global sports betting market, both regulated and unregulated, is worth up to \$3-trillion. Around 65 per cent of that figure is spent on football betting, with the Asian market the center of sports gambling.

The Chinese, Indian and Southeast Asian markets, where betting is largely illegal, have been identified as the principal operational jurisdictions for unregulated bookmakers.

In China, where up to 1\$-billion dollars can be gambled on a single game of football, the ratio of legal bets to illegal bets is 1:10.

The global licensed and regulated gambling market (all products including: betting, poker, casino, bingo, gaming machines and lotteries) is forecast to reach \$533 billion in 2017. That is a 47% increase from the \$363 billion market figure in 2007.

The gross gambling yield* (GGY) of the licensed and regulated global football betting market is expected to reach \$80 billion in 2017.

The gross gambling yield (GGY) from the global mobile device betting market is expected to generate an increasing share of all interactive gambling reaching nearly 44% by 2018 and representing around 5% of total gambling. This trend is driven by growth in smartphone and tablet penetration.

As mobile gambling is exponentially growing, the average mobile gambling spend per adult in the European Union (EU) is expected to grow from just over \$1 in 2010 to over \$17 by 2018.

Popular types of football bets

TRADITIONAL BETTING

When betting with a bookmaker you can only bet on the odds they offer, only having the option to back a certain outcome. The odds set by bookies include their margin meaning they price markets in their favor with unfair odds. Bookmakers effectively make money by building in a margin/over-round into their odds.

BETTING EXCHANGES

Instead of being limited to the odds set by bookies, and only having the option to back a certain outcome, an exchange allows users to go head-to-head against each other by either backing or laying. It differs to traditional sportsbooks by allowing bettors to bet against each other, rather than a bookmaker.

FULL-TIME RESULT (1X2)

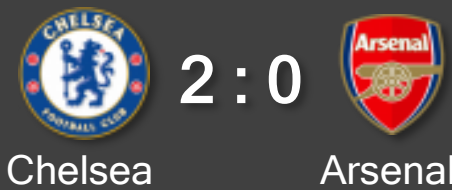
This is by far the most common type of football bet and is usually based on the match result after 90 minutes where the punter predicts a Win, Draw or Lose outcome with a total of three possible outcomes.

GOALS (UNDER/OVER)

Two-way bet regarding whether the total number of goals scored will be more than the one quoted or less. In most cases, the bet appears to exceed or even be less than 2.5 goals and two possible outcomes.

Over 3.5 goals	2.80

CORRECT SCORE (CS)

Under these types of football bets, one has to predict the correct score within the normal 90 minutes of football action. The odds tend to be quite high because of the fact that there are many possible outcomes.

LICENCING AND COMPLIANCE

Licensing challenges, regulatory repercussions and compliance requirements. Very strict gaming regulations and legislation that significantly varies between countries and governments.

Goal Bonanza is a stateless, non-regulated cryptocurrency platform that is not subject to any regulatory or licensing requirements.

UNIQUE CUSTOMER PROPOSITION

Lack of innovation and differentiation as sportsbooks are using the same 'off-the-shelf' solutions provided by monopolized and regulations heavy marketplace of gaming providers. Goal Bonanza is brand new gaming concept offering different football betting experience unlike anything else on the market.

LACK OF PRIVACY

Identity verification requires substantial personally identifiable information including form of identification, credit card and bank account details. Goal Bonanza provides the ability to play without any forms of identification. No record of deposits/withdrawals appearing on a monthly statement ensuring privacy is respected.

LOW RETURNS

Low returns and unattractive odds set by bookmakers that effectively balance their books in a way that allows them to make money irrespective of the result. Goal Bonanza doesn't set the odds and potential returns but the players do. The bigger the crowd the bigger the returns. No limits. Period.

Why do people like to bet so much on football? Well, the first reason is because most people love to gamble. The second reason why people love to bet so much on football is because people love football. In our modern culture we no longer go to war and battle one another, so instead we enjoy competition through the safer medium of sport.

We all like to pick a favorite team so we can get together with fans of the same team, celebrating when they win or supporting one another should they lose.

Guys like to think they can predict the outcome of a football game. They like to talk trash to each other and that trash talk can escalate into a bet.

Spending a dollar to maybe make a million as in buying a lottery ticket is one thing but when it comes to football betting, there is a little more to it.

The science behind Goal Bonanza

In a simple 6-from-49 lottery, a player chooses six numbers from 1 to 49. If all six numbers on the player's ticket match those produced in the official drawing then the player is a jackpot winner. For such a lottery, the chance of being a winner is 1 in 13,983,816. Our main challenge was to design a model with a total of 10 available game score outcomes where there will be at least one winner in every football game available for betting. From statistical perspective and in practice, a football game has significantly more than 10 possible outcomes as displayed in the table on the right.

In the table provided above, you can see a matrix with historical data from all football game scores in the top 4 English leagues in the last 126 years. In 66.1% of the total games played, neither team scored more than 2 goals. This accounts for a total of 9 outcomes. From statistical perspective, in 33.9% of the games played, at least one team scored 3 or more goals. All though not impossible, it would be very hard to predict the final game score out of 49 options. We decided to improve the odds and simply bundled those 33.9% in "Goal Bonanza" as the 10th outcome in our model.

Game mechanics

Goal Bonanza is a lottery game where players predict the final score of a single football game by backing at least 1 out of 10 available options. Unlike traditional bookmakers and betting exchanges that offer unattractive odds and low returns, in the Goal Bonanza lottery the size of the pot drives the potential returns. **The bigger the pot is, the bigger the potential returns are. The bigger the potential returns are, the bigger the incentive to place a bet for a chance to win big profits.**

For example, 80,000 players wager a total of 100,000 tokens worth \$1 each, on a single football game. 180 tokens are wagered on 0-0, a scoreless draw. If the game ends 0-0, the players that wagered those 180 tokens will split the winnings proportionally. Every winning token generates a return of 555 tokens or \$555.

Players can also use hedging strategies and bet on more than one outcome to improve their chances. For example, backing 3 outcomes statistically increases the chance of winning a bet to 30%.

Goal Bonanza is a brand new product that combines lottery mechanics and football betting to unlock the potential of unlimited returns for players but also requires skills and know how unlike plain lottery. This is what makes this game a unique proposition in the football betting market.

Real game simulation

Real Madrid is a big favorite hosting Levante in the 3rd round of Primera Division at Santiago Bernabeu. The average odds for a home win are 1.10, with 19.00 for an away win and 10.00 for a draw. Levante is undefeated in the last two games, they are playing very well and tight at the back, and John believes Levante might be able to snatch a low scoring draw in Madrid.

The crowd is backing a home win for Real Madrid and most of the wagers go on “GOAL BONANZA” and home win game scores. John however, wagers 5 tokens on 0:0, 1:1 and 2:2, each and hedged his draw prediction with 15 tokens on “GOAL BONANZA” to cover his losses in case Real Madrid trashes Levante. On the right you can see the expected distribution of stakes in a football game with a home team as a huge favorite.

John just made profit of \$45,782.85 (Total returns - total stake). No traditional bookmaker or betting exchange could match this. If the game ended up with a high scoring home win, John would get his stakes back by hedging his draw bets with 15 tokens on “GOAL BONANZA” at 2.10 to 1. Real Madrid was a big favorite in the match and the crowd is heavily backing the most probable outcome. The potential returns on the less probable outcomes are exponentially growing and the crowd is more keen to back an underdog. This behavior on the other side increases the potential returns for backing a home win that no traditional bookmaker or betting exchange can match.

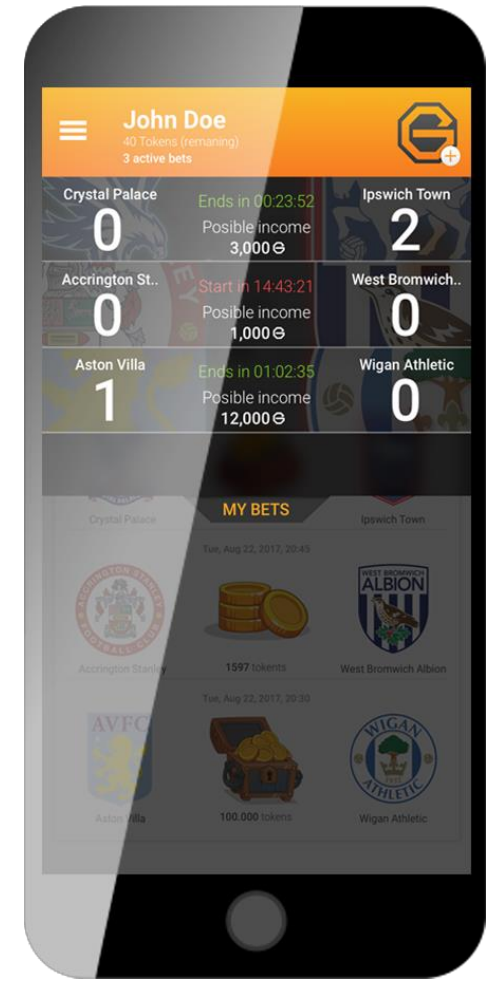
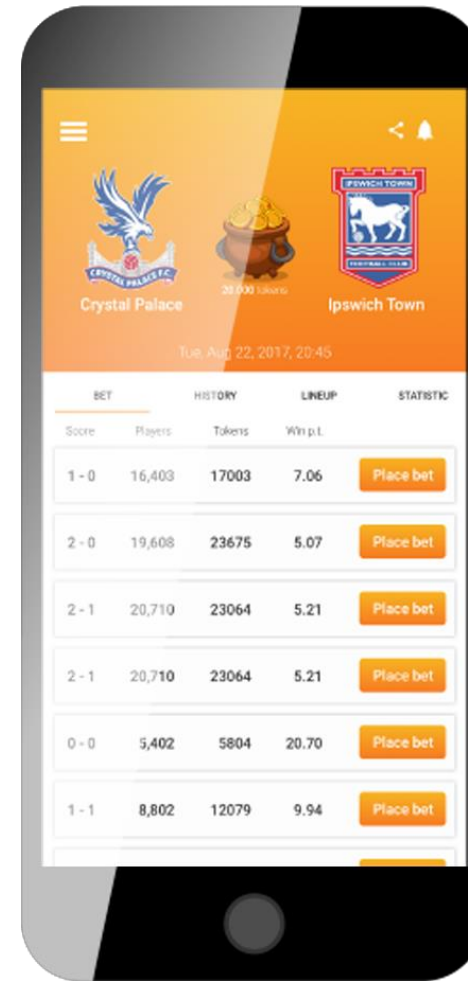
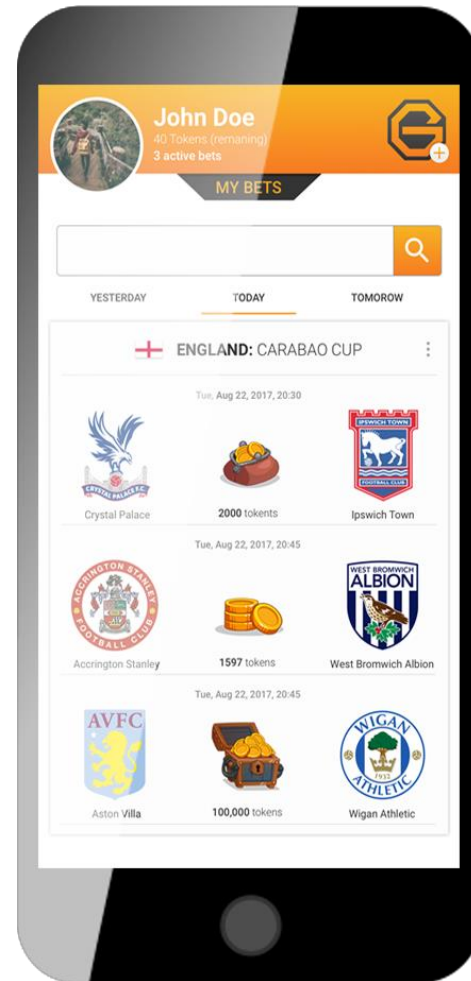

Gamification, retention and acquisition

Goal Bonanza will include a **gamification platform, embedded in the core game mechanics**, that will incentivize players to perform different actions and tasks, but ultimately to keep on playing.

The gamification platform will tap into the basic desires and needs of the players, and leverage their natural desire for **competition, achievement, status, recognition and collaboration**. Goal Bonanza will increase users engagement by rewarding them when they accomplish the desired tasks.

Rewards such as badges and tokens will be used to elevate status by showcasing their talents, expertise, and accomplishments.

As players wager and make predictions, they advance up to Veteran level and **unlock different privileges, token bonuses, new account features and new game features.**

Players can win tokens, create communities and make friends, can **challenge their friends or other players to make a bet on a football game**, receive challenges from friends and other players, unlock an advanced notification system and receive alerts when their favorite team is available for betting, when their biggest competitor made a bet, receive notifications on the football games open for betting with the highest pot and much more.

Advanced status players will be able to follow the best punters, follow their predictions, and veteran level players will be able to participate in **special power-play games with a big bounty for the winners.**

Players will also be able to unlock the **referral program** and earn 1 token for every referred player that will reach professional level.

This way we will create a formidable force of Goal Bonanza advocates that will promote the game and **drive acquisition of new players.**

Game essentials

Summary

- 1 Players will have between 150 and 200 football games available for betting on weekly basis. Football games from all major national and international competitions will be available for betting.
- 2 Multiple 3rd party API services will be used to feed available competitions, game schedules and game scores to ensure data quality and integrity via multi-tier data validation system.
- 3 Football games from selected competitions will open for betting with 10 GOAL tokens Goal Bonanza sponsored bounty, 24h prior to match start. Bets will be accepted until the start of the football match.
- 4 Minimum accepted bet will be 1 GOAL token valued at 0.0004 ETH per 1 GOAL token on launch date. Players can wager a minimum of 1 GOAL token on at least 1 of the 10 available outcomes.
- 5 The game pot will be shared between players that successfully predicted the game outcome. In event of no winning bets, the pot is thrown in a jackpot game organized every month for players with account level 5 only.
- 6 Goal Bonanza will withhold 4.75% retainer from every football game pot as the games organizer.
- 7 Withdrawals will be available only for players with account level 3 or above. Users will have to have an ERC20 compatible token wallet to make a withdrawal. Players collecting winnings by selling tokens on an exchange.
- 8 Players will be able to earn 1 token for every referred player that will reaches account level 3 via the referral program. The referral program will be available when user unlocks account level 2.
- 9 Players will be able to earn win additional tokens as a reward for completing various achievements, challenges and milestones. Withdrawals of reward tokens will be available only for players with account level 4 or above.
- 10 Goal Bonanza doesn't require any identity verification, submission of forms of identification, credit card and bank account details. Players in Goal Bonanza are anonymous and personal data privacy is guaranteed.

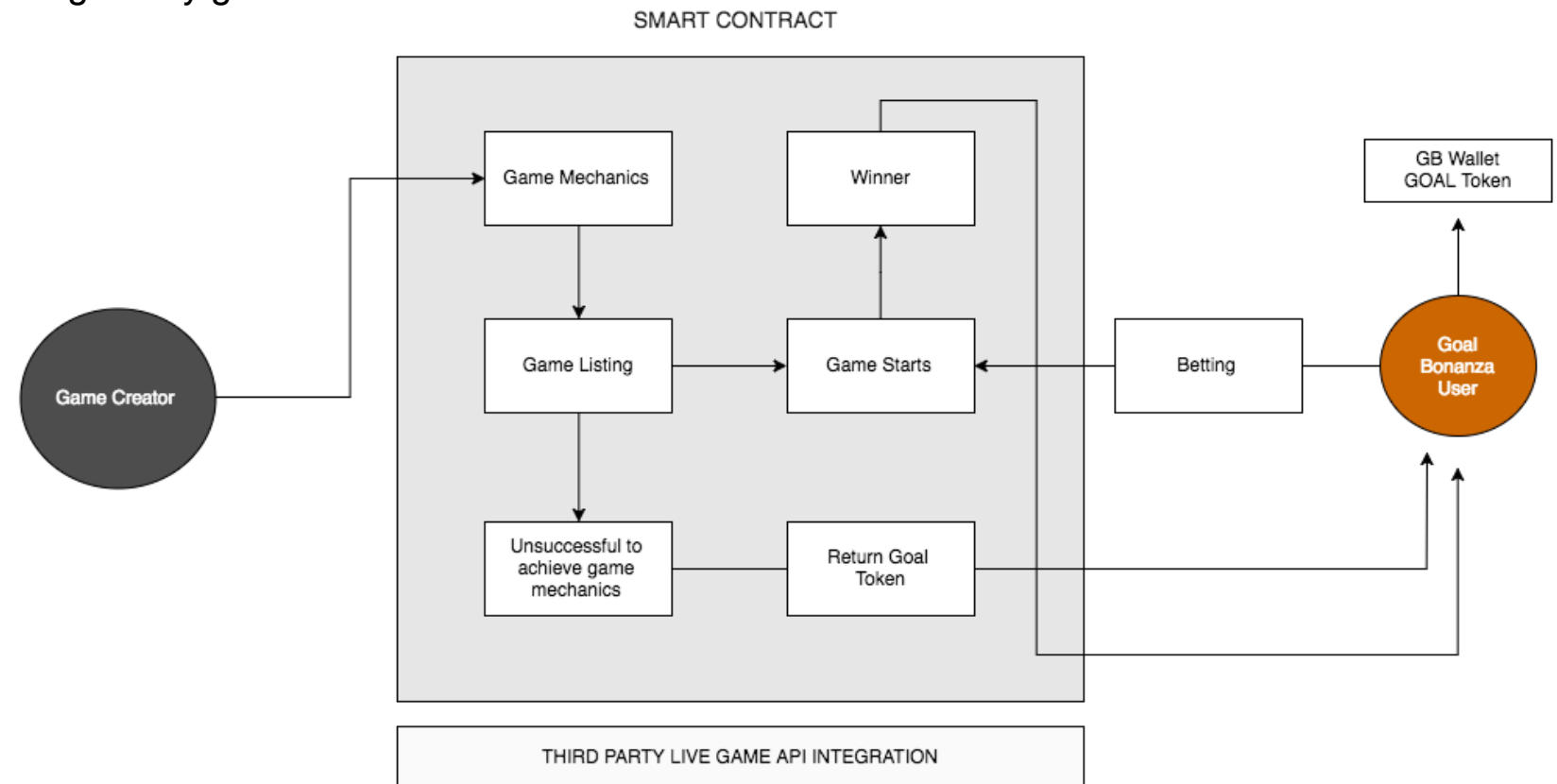

Goal Bonanza smart contract

Goal Bonanza users will interact with a front end interface written in Javascript that creates a smart contract through the Web3 protocol. The smart contract defines the mechanics of the game such as total number of users that participate in a single game, wagered tokens per outcome, distribution of winnings, fulfillment of achievements, distribution of bonuses and rewards, and other rules and restrictions. This front end will provide general information about the game as well as the most up-to-date scores of the football team that are competing at any given time.

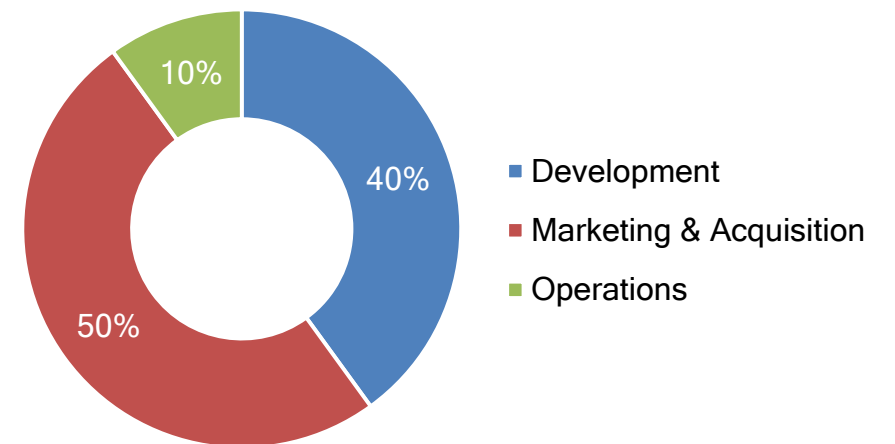
